

# A Change Agent

▲ Through her gift, Judy Winkelpleck is fulfilling her desire to serve, help people and create a better world.

**Judy Winkelpleck's** accomplishment-packed life was shaped, in part, by welding.

Growing up on her family farm in Ogden, Iowa, Winkelpleck learned how to weld at a young age. Her skills were often called upon to fix broken equipment. Neighbors in need of repairs even relied on her. As the sparks flew around the young woman, she would wonder what could be done to prevent things from breaking in the first place.

"Growing up on a farm was a good education, and I was taught by my parents to be helpful to others, to create a better world," she said. "I've always been drawn to what is and what could be."

Winkelpleck views herself as a change agent, pursuing opportunities to "invite people to new ideas and new ways of thinking." She's brought that philosophy to positions with some of the most significant organizations in lowa, including the Civic Center of Greater Des Moines, Pioneer Hi-Bred International and Iowa State.

"I always had positions in which there was something that needed to be addressed now, as well as the opportunity to build something for the future," she said.

She did graduate work at Iowa State, earning a master's degree in 1971 and doctorate in 1974, both in sociology, and a master's degree in counseling in 1975. Winkelpleck also has a Master of Divinity degree from the St. Paul School of Theology, and has done pastoral service at churches in Iowa and Arizona.

Her nonprofit career, as she calls it, has been as impactful as her professional life, including serving on the national and state boards of the Alzheimer's Association and leading the creation of Bernie Lorenz Recovery, a residential care facility for women recovering from chemical dependency. At one point, she served on 12 different boards.

That drive to serve, to help people and to create a better world is behind the Judy M. Winkelpleck Endowed Scholarship, which she established with a deferred gift through her estate.

The scholarship will support women over 30 who have returned to lowa State to pursue a long-desired career goal. Winkelpleck particularly hopes to impact the lives of underrepresented women. Her hope is that scholarship recipients will take their life experiences and their lowa State degrees out into the world and address pressing problems such as climate change and food insecurity.

When Amy Yager's two oldest kids arrive home from school, it isn't unusual for them to dive right into their homework.

They're just following their mom's example.

A mother of three, Yager is a non-traditional student pursuing a degree in child, adult and family services, with the goal to become a children's mental health specialist.

"I love school, and I totally nerd out on my homework," she said. "I love the coursework in my major because I feel it applies to everyone's real life. It makes me a better person."

At one point, higher education seemed out of reach for Yager. Any plans she may have had for college were tabled when she became pregnant in high school.

"I never really felt like I could go back to school because I was a teen mom," she said. "But I was working at a mental health facility that closed. I lost my job and was provided financial support to go back to school."

She attended a community college for two years before enrolling at lowa State. The cost of school remained a concern, though, not to mention the responsibilities of being a mom to three youngsters. Fortunately, she received an Ethel Whitney Scholarship, intended especially for non-traditional students in the College of Human Sciences.

"The scholarship helped me a lot. I live an hour away from campus and I've been able to cover childcare costs, for example. It's helped me balance my life as a student and being a mom."

Your IRA is a tool that helps you save for your retirement years. And, when retirement comes, your IRA also provides a smart way to support the institutions you care about most. When you give through your IRA, you not only make an impact on Iowa State students, you protect your hard-earned savings from taxes and qualify for benefits in return.

#### Give From Your IRA

- Name the Iowa State University Foundation as a beneficiary of your **IRA.** To make this gift, simply update your beneficiary designations by requesting a form from your provider (or go online to update them).
  - → + The benefits: when left to loved ones, your IRA is subject to income tax. But, when left to a nonprofit like the foundation, we receive the gift tax-free, allowing us to put your hard earned savings to work for future Cyclones.
- Make a qualified charitable distribution from your IRA to the foundation. If you are 70½ or older, you can transfer any amount up to \$100,000 per year directly from your IRA to a qualified nonprofit like the foundation.
  - > + The benefits: this gift does not generate income so you benefit whether you itemize on your taxes or not. It can also decrease the amount of Social Security that is subject to tax and lower your Medicare premiums. If you are 72 or older, your gift can also be used to fulfill your required minimum distribution.

## Your New Year's Resolution:

### **Review Your Estate Plan**

A new year means new resolutions. One task that is often overlooked? Reviewing your estate plan and updating it as needed. As you choose your goals for 2021, make sure this important task is on there. Use the checklist below to help.

- □ **Review your will,** checking for any updates that may need to be made due to a recent life event, tax law changes or because you want to add a gift to a place you care about, like Iowa State University, in your plans.
- ☐ Check that the executor you've named is still the qualified individual you want to manage your estate, resolve claims and distribute the designated portions of your estate to your chosen beneficiaries.
- □ Confirm the guardian named for those under your care is still the person you want to care for your dependents. If your dependents were minor children who are grown now, does a guardian still need to be listed?
- □ **Update beneficiaries designated** for your insurance and retirement plans to make sure you haven't named a deceased loved one or former spouse. Make sure you also notify your beneficiaries so they can receive the funds you intend.
- □ Name a health care power of attorney to guide your family and health care providers when you are unable to make decisions for yourself.

## HOW TO REMEMBER IOWA STATE UNIVERSITY IN YOUR WILL OR TRUST

Share the following language with your estate planning attorney to add the Iowa State University Foundation to your will or living trust.

I give, devise and bequeath to the Iowa State University Foundation, a not-for-profit corporation existing under the laws of the State of Iowa and located at Ames, Iowa, \_\_\_\_\_ (percent of my estate, dollars, property, securities, etc.) to be used for \_\_\_\_\_ (however you wish for your gift to be used) at Iowa State University.
