QUALIFICATIONS:

For a corporation or foundation that has/have provided significant philanthropic support, dedicated and long-term service, and creative leadership to Iowa State and the Iowa State University Foundation by:

- Leadership level giving of \$500,000 or more in cumulative gifts or pledges to benefit the university and/or equipment, technology, facilities or other gifts in kind.
- Corporate representation on college advisory committees, boards, etc.
- Offering internships and recruitment opportunities for students, sponsoring faculty research or other similar programs to benefit students and faculty of the university.

SELECTION CRITERIA:

70 PERCENT IS WEIGHTED ON GIVING AND ITS IMPACT

- What is the nominee's total giving to the university?
- What is the duration of their giving? Has their giving been consistent?
- To what area(s) of campus have gifts been given?

15 PERCENT IS WEIGHTED ON SERVICE TO IOWA STATE

- List committees, boards, activities that this corporation/foundation has been involved with at lowa State University.
- What effects has this service had on the university/college/department?

15 PERCENT IS WEIGHTED ON RESEARCH AND RECRUITMENT

- What has this corporation/foundation done to provide recruitment and research opportunities for students?
- What has this corporation/foundation done to provide research opportunities for faculty?

PLEASE NOTE:

- All nominations are kept on file and confidential.
- Any nominee not chosen will be reconsidered for two years following their original nomination with the consent of their nominator(s).
- Nominators are strongly encouraged to update nomination materials annually.


